PRODUCT NAME: Spa Lift Elite Pool/Spa Access Lift

APPLICATIONS:

- On Ground & Partially Recessed Pools & Spas with walls from **21-inches (53.34cm)** up to **68-inches (172.72cm)** high and up to **14-inches (35.56cm)** wide.

SUBMITTALS:

- Alternate make or model lifts will not be considered unless equal to the specified product in every respect. Alternative products must be submitted for approval no less than ten (10) calendar days prior to the bid due date. Submittal data must include complete documentation relating to all the specified features and include all manufacturer's sales literature, specification sheets, installation/operation manuals, engineered drawings and documents that support the strength, service capacity, and the ability to meet the appropriate Federal Regulatory Standards associated with the product.

QUALITY ASSURANCE:

- The product must be a standard product of a company registered with the United States Food and Drug Administration (FDA) as a class 1 medical device manufacturer and that is regularly engaged in the manufacture of commercial grade swimming pool and spa accessibility equipment.
- The product shall be structurally capable of supporting a **300 pound (136.08kg)** load capacity and static load tested to 1.5 times the rated load.
- The product shall be certified to be compliant with UL test standard 60335-2-1000 Standard of Household and Similar Appliances: Particularly Requirements for Electrically Powered Pool Lifts.
- The product shall be tested and confirmed to comply with design standards outlined in the United States ADA Accessibility Standards for Accessible Designs.

SPECIFICATIONS:

- The products main structure shall be constructed of type 304 stainless steel; no dissimilar metallic components shall be allowed. The product shall be finished with a minimum 4-mil thick, UV resistant powder coat finish. All fastening hardware shall be of type 316 stainless steel. Product shall be supplied with a Linak Actuator suitable for medical use, a separate wall mount battery charger, a hand-held controller, and a 24-volt rechargeable battery.
- The chair of the product shall be of a rigid one-piece, polyethylene, molded design. The minimum seat width shall be **18-inches (45.72cm)** and the seat back shall be a minimum height of **17.5-inches (44.45cm)**. The seat shall feature dual flip-up arms and supplied with a 2-inch (5.08cm) wide adjustable safety belt with hook and loop fasteners.
- The product shall be capable of accommodating an anchor set back distance of **10-inches (25.40cm)**.
- An adjustable and removable footrest that moves with the seat shall be supplied with the product.

WARRANTY:

- Product shall have a minimum 5 year structural and 5 year pro-rated electronic warranty.
